- r. Legislative Liaison (Joan Payton)
  - The Oregon court goes on to make one distinction of animals from other forms of property— while still importantly maintaining they ARE property—is that animals have welfare statutes applied to them: protections distinct to animals and inapplicable to other inanimate forms of property. The court also quoted a prior ruling that recognized animals as "sentient beings capable of feeling pain, stress, and fear," which is another part of this ruling the animal rights proponents have latched onto. However, the court makes the very important distinction that the animal rights proponents fail to acknowledge, that "[t]o be sure, the protection given to animals under Oregon law does not place them on par with humans." With that said, the law does prohibit people "from treating animals in ways that humans are free to treat other forms of property
  - The court also noted that because of the animal welfare laws that do somewhat limit property rights in animals, that dog owner's privacy rights do not override an obligation to minimum care. An exam and medical judgement is not government scrutiny. It's very important to note that the court stressed that their decision was limited to the specific facts of this case, so it does not set precedence for future legal change. Also, the holding was certainly confined to LAWFUL seizures. The bottom line of this case was clear: the ruling has nothing to do with changing the legal status of animals but is rather an interpretation of the

current legal property status of animals when it comes to the Fourth Amendment and criminal investigations.
