 - b. Option #2: Require for all dogs (10 votes)
 - c. Option #3: Eliminate DNA Requirement (13 votes)
 - d. Option #4: Require only for titles in front of the name (FC,AFC,CH) (1 vote)
 - Motion to require all dogs competing at Nationals to be rescinded; 5 yes, 2 no. Motion passed.
 - Motion to restore the rule for DNA to be required for dogs 2-years of age and older for the 2016 Nationals, and to form a committee to make a formal recommendation for DNA requirement. 5 for, 2 opposed.

b. Standard Review Committee
