If you are traveling North on Hwy 82/395 from Umatilla:

Take Exit #113, into Kennewick, after exiting and going down the hill Turn left onto W. Hildebrand Blvd., and a left onto Southridge Blvd., and turn right onto Christenson Rd., go up & over Hwy 82. You will see us up ahead on the left. **PARK ONLY IN THE MOWED PARKING AREA.**

If you are traveling South on Hwy 395 out of Kennewick or from Clover Island Inn:

Turn right onto Hildebrand Blvd. Then left onto Southridge Blvd., then right onto Christenson Rd., go over Hwy 82. You will see us up ahead on the left. **PARK ONLY IN THE MOWED PARKING AREA.**

If you are traveling from Yakima on Hwy 82:

Take Exit #113, into Kennewick, after exiting and going down the hill Turn left onto W. Hildebrand Blvd., and a left onto Southridge Blvd., and turn right onto Christenson Rd., go up & over Hwy 82. You will see us up ahead on the left. **PARK ONLY IN THE MOWED PARKING AREA.**

MOTELS:

Baymont Inn; 509-736-3326. \$10.00 per pet per night, and, The Hampton Inn; 509-820-3023. Not a pet friendly place.

Note: In the Handler section, we cannot assume, just because you are the owner, you will be handling the dog, please fill in the handler section even if it duplicates info.

The 1st brace casts off at 8:00 am Sunday and Monday.

Remember to get there in advance and be sure to check-in at the Secretaries Table when you arrive. Your cooperation in this matter is appreciated.

One additional note; the weather here in Eastern Washington is subject to change without warning so be prepared for anything.

There will be dry camping on site in the designated parking area. **No Open Fires!** Overnight parking for RV/Trailers, etc is available from Thursday night on the grounds thru Tuesday morning ONLY. Park in designated mowed area only! Stake out horses in designated areas. Water is limited. This is private land, please be respectful of owners parking instructions.
