2026 Judges

1. **Beverly R. Andersen** is a prominent American Kennel Club (AKC) conformation judge based in Scottsdale, Arizona.

Judging Credentials

As of 2026, she is an established judge with a wide range of breed approvals. Her credentials include:

- Approved Breed Groups: She is fully approved to judge the Sporting Group and the Hound Group.
- Individual Breeds: In addition to the groups above, she is approved for several breeds in the Working and Toy groups, as well as Best in Show (BIS).
- Judging Style: She is known for her extensive experience in the show ring and is frequently invited to judge major competitions across the United States.

Background in the Sport

- Kennel Prefix: Historically, she has been associated with the breeding and showing of purebred dogs, particularly within the Hound or Sporting groups, which formed the foundation of her judging career.
- Professionalism: She is recognized for her adherence to AKC Rules, Policies, and Guidelines, focusing on breed standards and sound movement.

2. **Rick Gschwender** is a prominent American Kennel Club (AKC) judge and long-time preservation breeder based in Milford, Michigan.

Career & Expertise

Judging Career:

- He has been judging since 1982. Initially starting with a few breeds, he gradually expanded his expertise and is now licensed to judge the Herding and Working groups.
 - Major Assignments: He has judged at the prestigious Westminster Kennel Club Dog Show multiple times, including judging the Herding Group in 2006 and the Working Group in 2024.
 - Breeding: Gschwender began his journey in the dog world in 1973 with Old English Sheepdogs. He later became well-known for breeding Bouviers des Flandres under the "Rendezvous" kennel prefix with his wife, Debra.

Background

- Early Involvement: His interest in the Bouvier breed began in the late 1970s when he and his wife sought a protective, intelligent companion for their home.
- Philosophy: As a judge, Gschwender emphasizes structural integrity and movement, comparing each dog strictly to its official breed standard to find the specimen that best represents its type.

3. **Linda Hurlebaus** is a highly prominent figure in the American purebred dog community, recognized as a breeder, former professional handler, and elite American Kennel Club (AKC) judge.

Professional Career in Dog Sports

- Early Experience: She began her journey in the sport of purebred dogs in 1973 with Old English Sheepdogs.
- Breeding and Handling: Before moving into judging, she was a breeder of Golden Retrievers and Cavalier King Charles Spaniels. She also worked as an all-breed professional handler for 25 years.
- AKC Involvement: Hurlebaus has held several key staff positions at the AKC, including working in the Events Plans Department and serving as an Executive Field Representative for the Southeast United States.

4. **Gloria Kerr** is a prominent American Kennel Club (AKC) licensed judge and former professional handler based in Arizona. Her career in the dog show world spans over five decades, with a specialized focus on Golden Retrievers.

Professional Background

- Breeding: Under her Krishna Kennels prefix, she has bred and titled numerous champions across several breeds, including Golden Retrievers, Akitas, Pembroke Welsh Corgis, and Chinese Cresteds.
- Handling: She became an AKC licensed professional handler in 1974, finishing dogs in every AKC group.
- Judging: Licensed as an AKC judge in 2000, she is now approved to judge:
 - Sporting Group (All breeds)
 - Herding Group (All breeds)
 - Toy Group (All breeds)
 - Non-Sporting Group (All breeds)
 - Select breeds in the Working and Hound Groups
 - Junior Showmanship and Best In Show

Judging Achievements

Kerr has judged prestigious events globally, including assignments in Australia, Korea, China, Canada, Sweden, and Brazil. Notable honors include judging National Specialties in the U.S. for breeds such as:

- She is known for her philosophy that "movement is the final determination of the best conformation" and emphasizes the importance of a dog's original purpose.

5. **Richard Powell** is a highly respected American Kennel Club (AKC) judge based in Palmyra, Pennsylvania, originally from England. He is a prominent figure in the dog show community, known for his expertise in Terriers and his "artistic eye" for breed standards.

Career & Background

- **Early Life:** Powell began his involvement with show dogs in England, working with English Cockers and English Setters.
- **Move to U.S.:** He moved to California in 1976 to pursue a career with Terriers, apprenticing under world-renowned handlers like Ric Chashoudian and Wood Wornall.
- **Professional Handling:** Alongside his wife Sue, he operated a successful boarding and handling business on the East Coast.
- **Breeding:** He is notably recognized for breeding and showing Welsh Terriers(Happitails Welsh), Cairn, Norfolk, and Wire Fox Terriers.

Judging Profile

- **Qualifications:** Licensed to judge the Sporting, Terrier, and Toy groups, as well as various Working breeds (Giant and Standard Schnauzers), Poodles, and Dachshunds.
- **Major Assignments:** He has judged at prestigious international venues, including the Westminster Kennel Club Dog Show(Terrier Group in 2022) and the Montgomery County Kennel Club (Best in Show and Best Brace in Show in 2025).
- **Philosophy:** Powell emphasizes balance, symmetry, and "the eye"—an artistic understanding of breed quality and movement.

He resides near Hershey, Pennsylvania, with his wife Sue. His interests outside of the show ring include collecting old cars, gardening, and raising show chickens.

6. **Harry "Butch" Schulman** is a prominent American Kennel Club (AKC) judge based in Louisville, Kentucky, with extensive experience as a breeder and professional in the dog sport.

Dog Sport Background

- **Breed Involvement:** He is a long-time breeder of Collies and has extensive experience with Doberman Pinschers. He is also a Golden Retriever owner.
- **Judging Qualifications:** Schulman is a licensed AKC judge approved for multiple groups, including:
- Herding Group (notably judged at the 2017 National Dog Show).
- Working Group.
- Sporting Group (portions).
- Terrier Breeds (selected).

- **Heritage:** He is the son of Dorothy Schulman, a former AKC judge and renowned breeder of Collies and Lhasa Apsos.

• **7. Nancy Talbott** is a prominent American Kennel Club (AKC) judge based in Riverside, California, recognized for her extensive expertise in Sporting dogs. As of 2026, she has over 30 years of judging experience and is a deeply respected figure in the Golden Retriever community.

Professional Background

- **Career:** She is a retired teacher and special education administrator.
- **Kennel:** She operates under the kennel name Belgold (originally associated with Golden Retrievers and later Labradors).
- **Judging Specialties:** Licensed to judge the Sporting Group, she began with Golden Retrievers in 1991 and Labrador Retrievers in 1993. She has judged internationally in countries including Canada, Sweden, Australia, South Korea, and Indonesia.

- Talbott is an advocate for "dual-purpose" dogs, emphasizing that Golden Retrievers should maintain the balance between conformation (physical appearance) and their original field-work purpose. She prioritizes breed hallmarks such as temperament, balance, gait, and correct coat texture in her evaluations.

1. **David Swartwood** is a highly experienced multi-group dog show judge from Canada who frequently accepts assignments for the American Kennel Club (AKC) and other international organizations.

Professional Background

- **Breeding Expertise:** He has been breeding and exhibiting English Springer Spaniels under the "Bryden" kennel name for over 40 years. He has also bred Miniature Wirehaired Dachshunds ("Prelude") for over 25 years and has experience with Boston Terriers, Lhasa Apsos, Pugs, and British Bulldogs.
- **Judging Credentials:** Licensed by the Canadian Kennel Club (CKC), he is authorized to judge various groups across Canada and internationally.

- **International Experience:** He has judged in numerous countries, including the USA, Australia, Argentina, China, Italy, Japan, South Africa, and New Zealand.
- **Leadership Roles:** He has served as the President of the Erie Kennel Club and as the Training Director for the Admiral Perry Obedience Training Club.

3. **Dr. Donald Sturz** is a prominent figure in the sport of purebred dogs, currently serving as the President of the Westminster Kennel Club. He is recognized as a multifaceted leader, having excelled as a junior handler, breeder, exhibitor, and judge for over 50 years.

Professional Roles & Leadership

- **Westminster Kennel Club President:** Appointed in 2022, he is the first openly gay president in the club's history.
- **AKC Judge:** Adjudicating since 1990, he has judged major shows worldwide, including ten assignments at Westminster.
- **Career:** Outside of the dog world, he is an educator and mental health expert who has served as a school superintendent with a doctorate in clinical psychology.

Judging & Show Career Highlights

- **Westminster Best in Show:** He served as the Best in Show judge for Westminster in 2022, where he made history by awarding the title to a Bloodhound for the first time.
- **Junior Showmanship:** Ranked as the #1 Junior Handler in the U.S. for three consecutive years (1974–1976).

- Breeding and Showing: Active in the sport since 1970, she and her husband, Rick, operate Fantail Kennels, which is recognized as one of the top English Setter kennels in Canadian history.
